

THE FUTSAL PROJECT

PLAYER REGISTRATION & PARTICIPATION AGREEMENT

This Player Registration and Participation Agreement (“Agreement”) is entered into between **The Futsal Project, LLC** (“The League”) and the undersigned player and parent/legal guardian (“Participant”).

By signing this Agreement, the Participant agrees to comply with all rules, policies, and procedures established by The Futsal Project.

1. Program Participation

The Participant agrees to take part in The Futsal Project’s futsal league, training sessions, matches, and related activities.

Participation is voluntary and subject to compliance with this Agreement and all League policies.

The League reserves the right to deny, suspend, or terminate participation for violations of League rules or policies.

2. Registration and Payment Obligations

2.1 Registration Fee

Each Participant must pay a **\$10 registration fee** prior to participating in any League activity.

2.2 Match Fees

Each Participant must pay a **\$5 fee per match played**.

2.3 Absence Notification

If a Participant is unable to attend a scheduled match, they must notify The League **at least one (1) week in advance**.

Failure to provide proper notice will result in the Participant being required to pay the \$5 match fee regardless of attendance.

2.4 Non-Payment

Failure to pay required fees may result in:

- Suspension from activities
- Loss of playing privileges
- Termination from the program
- Referral for collection or legal enforcement

All outstanding balances remain legally owed to The League.

3. Inclement Weather Policy

Participants agree to follow The Futsal Project's Inclement Weather Policy, including:

- Immediate suspension of play upon thunder or lightning
- Mandatory shelter and waiting periods
- Compliance with cancellation notices

Failure to follow weather safety procedures may result in disciplinary action.

4. Injury and Medical Safety Policy

4.1 Injury Response

In the event of injury:

- League staff will assess the situation
- Parents/guardians will be notified
- Parents/guardians are expected to arrange prompt pickup

4.2 Continued Participation

If a parent/guardian is unavailable, the injured player will be removed from play and supervised until pickup.

The League will provide reasonable medical assistance to the best of its ability.

Medical clearance may be required before return to play.

5. Player Conduct and Anti-Harassment Policy

All Participants must demonstrate respectful and sportsmanlike behavior.

The following are strictly prohibited:

- Hate speech
- Harassment
- Bullying
- Discrimination
- Threats or intimidation

Participants who violate this policy may be immediately removed and subject to suspension or permanent removal.

Parents/guardians will be notified of serious misconduct.

No refunds will be issued for disciplinary removals.

6. Grievance and Dispute Resolution Policy

The League maintains a formal grievance process for disputes and complaints.

By signing this Agreement, the Participant agrees to:

- Submit complaints in writing
- Cooperate with investigations
- Respect confidentiality requirements

- Accept Committee decisions

The League reserves the right to impose temporary restrictions during investigations.

7. Liability Waiver and Assumption of Risk

The Participant understands that participation in futsal and related activities involves inherent risks, including physical injury.

By signing this Agreement, the Participant:

- Assumes all risks associated with participation
- Releases The Futsal Project, LLC, its owners, staff, volunteers, and affiliates from liability for injuries, damages, or losses
- Agrees that The League is not responsible for injuries occurring during matches, practices, or related events

This waiver applies to all League-sponsored activities.

8. Acknowledgment of Policies

The Participant acknowledges receipt and understanding of the following policies:

- Payment and Attendance Policy
- Inclement Weather Policy
- Injury and Medical Safety Policy
- Player Conduct & Anti-Harassment Policy
- Grievance and Dispute Resolution Policy
- Liability and Risk Policy
- League Handbook

These policies are incorporated into this Agreement by reference.

Failure to comply may result in disciplinary action.

9. Termination of Participation

The League reserves the right to suspend or terminate participation for:

- Non-payment
- Repeated absences
- Misconduct
- Policy violations
- Safety concerns

Termination does not relieve the Participant of outstanding financial obligations.

10. Legal Enforcement

This Agreement is intended to be legally binding.

Any breach may result in legal action, including recovery of unpaid fees, damages, and enforcement costs.

This Agreement shall be governed by applicable state law.

11. Entire Agreement

This document constitutes the full agreement between the Participant and The League.

No verbal agreements or informal arrangements override this Agreement.

Changes must be made in writing and approved by The League.

12. Participant Acknowledgment and Signature

By signing below, the Participant and Parent/Guardian confirm that they:

- Have read this Agreement in full
 - Understand all policies and obligations
 - Agree to comply with all League rules
 - Accept all financial and legal responsibilities
